

NOTICE OF THE OFFICIAL CALL FOR  
THE MASS MEETING OF THE NEW KENT COUNTY  
REPUBLICAN COMMITTEE

As Chairman of the New Kent County Republican Committee of the Republican Party of Virginia, and pursuant to the RPV Plan of Organization and in compliance with the NKCRC Bylaws, I, Mark Daniel, do hereby issue this Call for a Mass Meeting scheduled at New Kent County Administrative Building, 12007 Courthouse Circle, New Kent, VA 23124 or an alternate site, starting at 7:00 p.m. for the following purposes:

1. To reconstitute the New Kent County Republican Committee;
2. To elect a Chairman for the New Kent County Republican Committee;
3. To elect up to 230 Delegates to cast 46 votes at the Virginia State Republican Convention scheduled on April 29-30, 2016 at 2:00 p.m., JMU Convocation Center, Harrisonburg VA for the purpose of electing 13 At-Large Delegates (“National Delegates”) and 13 At-Large Alternate Delegates to the Republican National Convention to be held on July 18-21, 2016, Cleveland, Ohio, nominating two Electors At-Large to be voted for in the presidential election on November 8, 2016, electing a State Chairman, electing a National Committeeman and National Committeewoman, and for the transaction of such other business as may properly come before the Convention;
4. To elect up to 230 Delegates to cast 46 votes at the First Congressional District Convention, scheduled on May 7, 2016, 4:30 p.m., at James Monroe High School, 2300 Washington Ave., Fredericksburg VA for the purpose of electing a First Congressional District of the Republican Party of Virginia Chairman; electing three (3) members of the Republican Party of Virginia State Central Committee; electing three(3) Delegates (“National Delegates”) and three(3) Alternate Delegates (“National Alternates”) to the Republican National Convention to be held on July 18-21, 2016 at the Quicken Loans Arena in Cleveland, Ohio (or its alternate site) (the “National Convention”); electing one (1) Presidential Elector to be voted for in the presidential election on November 8, 2016; and transacting such other business as may properly come before the convention.

Registration begins at 6:15 p.m. and closes 10 minutes after the Mass Meeting's called time. A Picture ID is required. To complete registration, participants must sign the Virginia Republican Party's Pledge. Persons in line at 7:10 p.m. will be allowed to register.

Qualifications for Participation

All legal and qualified voters of New Kent County, under the laws of the Commonwealth of Virginia, regardless of race, religion, national origin, or sex, who are in accord with the principles of the Republican Party and who, if requested, express in open meeting either orally or

in writing as may be required, their intent to support all of its nominees for public office in the ensuing election, may participate as members of the Republican Party of Virginia in its mass meetings, party canvasses, conventions or primaries encompassing their respective election districts.

In addition to the foregoing, to be in accord with the principles of the Republican Party, a person otherwise qualified hereunder shall not have participated in Virginia in the nomination process of a party other than the Republican Party in the last five years.

A single exception to the above shall be approved for a voter that renounces affiliation with any other party in writing, and who expresses in writing that he/she is in accord with the principles of the Republican Party and intends, at the time of the writing, to support the nominees of the Republican Party in the future. A voter who utilizes the foregoing exception, and thereafter participates in the nomination process of a Party other than the Republican Party, shall not have the benefit of the exception as identified in this paragraph thereafter.

A person, who has made application for registration and meets all other requirements of the Qualifications for Participation, but whose name does not appear on the local registration books solely because of the books having been closed in connection with a local election, will nevertheless be deemed a legal and qualified voter.

#### Filing Requirements

Candidates for election to the position of Chairman of the New Kent Republican Committee must be in good standing with the committee, and shall file a written statement of intent to the Committee Chair, Mark Daniel, stating their intention to seek election as Chair by 5:00 PM, EST, March 10, 2016.

Candidates for election to the New Kent County Republican Committee, Delegate to the 1st District Convention, and/or State Convention shall submit a New Kent County Republican Committee Filing Form stating their intent to become a member of the New Kent County Republican Committee to the Unit Chair, Mark Daniel, and stating their intention to seek election as a delegate for each specific event. The official New Kent County Republican Committee Filing Form is being sent out with the Mass Meeting Call, and is also available from any of the Unit's Executive Committee members.

If only one candidate applies for New Kent County Republican Committee Chairman, that person will be declared as Chairman.

#### Registration and Fees

The doors will open at 6:15 with registration to begin at the same time. Any participant in line at 7:10 p.m. shall be allowed to register for the mass meeting.

There will be no registration fee to participate in the New Kent County Republican Mass Meeting.

To assist the operations and the administration of the 1<sup>st</sup> Congressional District Convention, a candidate filing fee of Five Dollars (\$5.00) is requested of each person standing for election as a delegate to the Convention. Failure to pay the requested filing fee will not result in disqualification.

Registration fees for the Virginia State Republican Convention, April 29-30, 2016 is thirty-five dollars (\$35.00). This voluntary fee is to assist the operations of the Republican Party of Virginia in supporting unit mass meetings and conventions, and the administration of the state Convention. Failure to pay the requested filing fee will not result in disqualification.
