### DIRECTIONS to Ruther Glen, Virginia

**Going North:** For those coming from the New Yorker by way of the Northern Neck, they would pass the New Yorker and come into Bowling Green (do not take bypass)and continue on at the Bowling Green light straight onto RT 207 which takes you 8 or so miles to the 95 interchange where you can either get on 95 or turn left on Route one and go several miles to Ladysmith which is essentially where the Timbers is.

**Coming South:** You all coming from up north, it's a straight shot south to exit 110. Ladysmith exit off 95 Hanover folks reverse, coming from your way on 95, it's a straight shot north to 110.
